## General Event Conditions

1. All participants take part in the event at their own risk. The organizer excludes all damages to property and persons.
2. The event will take place even in case of bad weather. If one of the event waters should not be fishable at the time of the event, we reserve the right to make modifications. In case all waters are „not fishable“ (Salza at 65 m<sup>3</sup> at the level Wildalpen and 30m<sup>3</sup> at the level Gusswerk), and there is no alternative water the participant will get a voucher for one or possibly more day licences that he can redeem later at the Salza, the Weiße Traun or the Deutsche Traun. This does not effect the hotel accomodation as there can be no refund for a shortened hotel stay even in case of bad weather or high water. There will be no refunding.
3. In case of illness of the leading group guide, the organizer can appoint another head guide. The following cancellation terms apply in case of withdrawal of the event participant:

### 4. Cancellation fee in case of cancellation of the event participant:

- until Februar 28, 2026 € 250,--
- up to 150 days before the start of the event: 50 % cancellation fee (will be credited by 60 % in case of participation of another class/course within one year at our company).
- up to 60 days before the start of the event: 75 % cancellation fee (will be credited by 40 % in case of participation of another class/course within one year at our company).
- up to 30 days before the start of the event: 90 % cancellation fee (will be credited by 20 % in case of participation of another class/course within one year at our company).
- 1 – 29 days before start of the event the entire amount is due.
